## **DECISION OF THE BOARD**

- 1. Joseph James Brider, who is 35, appeared before the Board today for further consideration of parole on a seven year nine-month sentence for rape and unlawful sexual connection with [withheld], abduction for sex and injuring with intent to injure.
- 2. Mr Brider's statutory release date is 4 February 2022.
- 3. This is Mr Brider's a second prison term. He was sentenced to two years in 2006 for burglary and arson.
- 4. Mr Brider was last before the Board in August 2020. The Board noted that significant violence was involved in this offending. He had completed the DTP and while initially reluctant to engage in the ASOTP, was undertaking the programme at the time of the last hearing and making good progress on it. He was not seeking parole at that time but instead said that he wanted to complete treatment. The Board requested a psychological report for today's hearing.
- 5. The psychologist records that [withheld]. Overall, Mr Brider was assessed as posing at a high risk of further violence and a moderate to high risk of sexual violence.
- 6. The psychologist also noted that Mr Brider had [withheld] but that this had stopped when he started on the DTP which he completed in 2019. He has since completed the ASOTP

programme. In relation to Mr Brider's intention to seek release to the [withheld], the

psychologist said that in the lead up to transitioning into the community from that

programme an assessment for ongoing support around substance abuse needs to be

completed. The psychologist also noted that while Mr Brider did not have any personal

supports in [withheld], a release to [withheld] would limit his potential exposure to previous

gang involvement.

7. Mr Brider has also been accepted onto the [withheld]. He is currently residing in Leimon

Villas and is now working outside the wire in [withheld]. He has had one guided release

to [withheld] and another is planned this week. In terms of the [withheld] pathway, it is

desirable he have a further four months of prison-based reintegration before he is

released.

8. [withheld] have a long waitlist. We do not know when a bed is available. However, given

Mr Brider's recent good progress to date and his looming statutory release date, it would

seem sensible to reschedule him to appear before the Board in October 2021. That will

give an opportunity for the initial in-prison reintegration work with [withheld] to take place

and for there to be an opportunity for a period on parole.

9. Parole today is declined. Without accommodation and other support available to him in

the community through [withheld] his risk remains undue.

10. Mr Brider will be seen again in October 2021 and by the end of October 2021 at the latest.

Mr Brider was advised today that he needs to be prepared to speak to the Board at that

hearing about his learnings from the programmes he has undertaken.
